A. ABOUT POLYU INNOHUB

Background

In order to further develop entrepreneurial culture and community, and support PolyU start-ups and start-up projects for their innovations and entrepreneurial venturing, a co-creation and co-working space named 'PolyU InnoHub' was launched in March 2017 on the 4/F of Jockey Club Innovation Tower ('JCIT', Core V). To further develop the GBA entrepreneurship support platform, InnoHub (Shenzhen) has also been established at the PolyU Shenzhen Base in the Nanshan District to support start-ups, tapping into the huge market, industry and government resources available in Shenzhen and the GBA.

PolyU InnoHub acts as a focal point and platform for community partnership, bringing different stakeholders together for pre-incubation/ incubation of ideas, innovations and start-ups, leveraging resources for multi-disciplinary collaborations and co-creation among PolyU members (faculties, students, graduates) and community partners.

The Knowledge Transfer and Entrepreneurship Office ('KTEO') of PolyU is the administrative unit responsible for the operation of PolyU InnoHub and the related programmes and activities.

Mission

To nurture and accelerate PolyU innovation and entrepreneurship projects and start-ups by providing infrastructure and pre-incubation/ incubation support.

B. SUPPORTS (see Appendices 1 and 2)

Each successful applicant will enjoy the following at PolyU InnoHub for a period of up to 12 months:

- Free Workspace at PolyU InnoHub (HK)
 Up to 4 fixed desks¹ and 6 access cards per project team or start-up
- Free Workspace at PolyU InnoHub (SZ)
 Up to 2 bookable hot desks² per project team or start-up
- Basic Storage in Fixed Desk Workspaces
 For example, mobile pedestal, for fixed-desk users only.
- Locker (upon request) (see Appendix 3)
- Shared amenities including bookable meeting room with video conferencing equipment, printer, common area, stable and secure Wi-Fi, shared pantry with vending and coffee machines
- Annual Membership of <u>Industrial Centre</u> of PolyU (upon separate application) (see Appendix 5)
 At a discounted membership fee of HK\$1,000 per individual user

C. APPLICATION

The 2023-24 cohort is now open for application.

Eligible Start-ups/ Projects	An entrepreneurship project team or start-up founded/ co-founded by student, alumnus or academic staff of PolyU, HKCC or SPEED³. They can be: PolyU academic-led start-ups⁴ PolyU start-ups or projects supported by PolyU entrepreneurship programmes⁵ PolyU start-ups or projects currently supported by other qualified programmes6 Other PolyU start-ups or entrepreneurship projects Eligible project team or start-up must apply through the Principal Applicant (PA)², who should be a student, alumnus or academic staff of PolyU, HKCC or SPEED.
Application Process	 Eligible project team or start-up must complete the online application form through the PA with the following documents uploaded on or before the application deadline. Interview with PA may be conducted. a 15-slide pitch deck (see Appendix 4) CVs of all team members a copy of student ID/ graduation certificate/ staff ID of each PolyU student, alumnus or staff Declaration of Use of PolyU Knowledge/ Innovations/ Technologies duly signed/ endorsed by PolyU academic staff, with supporting documents (if applicable) Company Shareholding Structure (applying to PolyU academic-led start-ups only)

⁴ PolyU academic-led start-ups are defined as a registered start-up company that are founded/ co-founded by PolyU faculty member(s) to commercialise their academic research outcomes. In the sole opinion of PolyU, 'academic-led' is usually evidenced by:

(a) PolyU faculty member(s)' ownership, in the form of equity shares, of the applying company; and
(b) a duly signed licensing agreement between PolyU and the applying company on the PolyU faculty member(s)' academic research

outcomes.

⁵ PolyU entrepreneurship programmes include PolyU Student Entrepreneurial Proof-of-Concept (POC) Funding Scheme, PolyU Micro Fund Scheme, PolyU Maker Fund Programme, PolyVenture Angel Fund Scheme – TSSSU-O/ TSSSU+, PolyU Entrepreneurship Investment Fund (EIF), GBA Startup Postdoc Programme, Good Seed, etc.

Assessment	The application will be assessed primarily based on the following criteria:

PolyU start-ups supported by PolyU entrepreneurship programmes (priority will be given to those supported within 3 years) c. PolyU projects supported by PolyU entrepreneurship programmes d. PolyU start-ups or projects currently supported by other qualified programmes e. Other PolyU start-ups or entrepreneurship projects
	Stage of Business In general, priority will be given to early-stage project teams or start-ups (i.e. start-ups established for less than 24 months at the time of application with less than 6 full time staff).
	Alternative Workspace Project teams or start-ups have no other workspaces/ offices will be given higher priority.
	4. Use of PolyU Knowledge/ Innovations/ Technologies Project teams or start-ups using PolyU knowledge/ innovations/ technologies such as class project, final year project, research project and patented technology will be given higher priority.
	5. Innovativeness, Sustainability and Scalability of the Business
	Impact and Reputation Project teams or start-ups contributing to PolyU's teaching and learning, research or knowledge transfer or enhancing PolyU reputation will be given higher priority.
	7. Contribution to PolyU InnoHub Community In the sole opinion of KTEO, the applicants will bring value to the PolyU InnoHub community through active participation of entrepreneurship activities and good interaction with students and peers. For re- application, previous InnoHub utilisation rate and any non-compliance of terms and conditions of usage will also be considered.







Appendix 3: Locker at PolyU InnoHub (Hong Kong)

Application and Allocation

- Locker allocation will be made on a first-come-first-serve basis and priority will be given to InnoHub user without fixed desk.
- 2. A maximum of ONE locker would be allocated to one team.
- 3. For any duplicate applications, only the last entry will be regarded as valid.

Use of Locker

- 4. The right of use of the locker is not transferable. All locker users should not share the locker and locker key to any other PolyU InnoHub teams/ start-ups.
- Locker users are not allowed to deface the lockers, such as putting up stickers, painting or making marks of any kind.
- All locker users should take full responsibility for the items stored in the lockers, ensuring the locker is properly locked after use. The University or PolyU InnoHub/ KTEO will not be responsible for any loss or damage to any personal belongings stored in the locker allocated.
- 7. Storage of any items which are of illegal nature, or would cause or be likely to cause a health hazard, security risk, physical danger or a nuisance to the environment or other residents (e.g. inflammable or perishable goods, pets, weapons) is prohibited. PolyU InnoHub/ KTEO shall be free to open the lockers and dispose of any possessions in the locker in such manner as it sees fit.
- 8. For hygiene reason, NO food or drinks of any kind should be kept in the locker.
- 9. Any violation of the locker rules and regulations by the locker users may result in termination of the use of lockers.
- 10. Upon expiry or early termination of your residency in PolyU InnoHub, all locker users should immediately remove all their possessions, vacate their allocated locker and return the key to KTEO. PolyU InnoHub/ KTEO shall be free to open the lockers and dispose of any possessions remaining in the locker in such manner as it sees fit.
- 11. PolyU InnoHub/ KTEO reserves the right on the explanation of the rules and regulations on the use of lockers when necessary.







Appendix 4: Pitch Deck Writing Guidance Notes

The pitch deck should be covering key items below for the assessment:

- Your products/ services
- Your business model
- Your key milestones
- Your team introduction
- Your R&D content and planning (if applicable)

The pitch deck is expected to be engaging and entertaining with **NO more than 15 slides.** Sloppy and lengthy text gives an applicant NO advantage.

What is a pitch deck?

A pitch deck (also known as a slide deck or pitch slide deck) is a communication tool to raise money with a potential investor. It is a brief presentation, often created using PowerPoint, Keynote, or Prezi, to provide the audience with a quick overview of the business plan.

There are tons of pitch deck templates on the Internet. Applicants are **free to choose** whatever they think is appropriate. Guy Kawasaki's "10/20/30 Rule of PowerPoint" - 10 slides, 20 minutes and no font smaller than 30 points, can be a useful reference. The ten slides proposed by Guy Kawasaki should include the following topics:

- 1. Problem Identified
- 2. Your Solution
- 3. Business Model
- 4. Underlying Magic/Technology
- 5. Marketing and Sales
- 6. Competition
- 7. Team
- 8. Projections and Milestones
- 9. Status and Timeline
- 10. Summary and Call to Action
