Biodata of the recipients of Outstanding PolyU Alumni Award 2019



Mr Chu Chen-on

Diploma in Design/ 1985 and Bachelor of Arts in Design (Graphic Design)/ 1988 (Hong Kong Polytechnic)

Mr Chu, Co-founder of October Pictures Limited and a Hong Kong Polytechnic design graduate, has played a key role in making Hong Kong known to overseas film studios. For years he has helped film directors all over the world identify Hong Kong as a setting for their stories and engaged in co-productions in Asia. The blockbusters he worked for during location shooting in Hong Kong include Lara Croft Tomb Raider: The Cradle Life 2003, Batman: The Dark Knight, Transformers 4: Age of Extinction, and the Korean movie The Thieves. He is a member of the Hong Kong Film Development Council and its Fund Vetting Committee that aims to nurture talents for the industry. In 2014 he was among 50 PolyU alumni featured in the exhibition "THE NEXT 50: Layers of Design Creativity from Hong Kong" to celebrate the opening of the Jockey Club Innovation Tower of the PolyU School of Design.



Dr Herman Lau Mun-cheung

Professional Diploma in Physiotherapy/ 1984 (Hong Kong Polytechnic); Master of Philosophy/ 2006 and Doctor of Philosophy/ 2011 (The Hong Kong Polytechnic University)

Dr Lau possesses vast healthcare management experience and is currently the Chief Executive of three hospitals in the New Territories East Cluster (NTEC) of the Hospital Authority, namely Bradbury Hospice, Cheshire Home, Shatin and Shatin Hospital. The first physiotherapist in Hong Kong appointed as a Hospital Chief Executive, Dr Lau has been a key driver for

volunteer service in hospitals, with his team of volunteers providing about 10,000 service hours monthly at the cluster. In 2008, he had initiated and coordinated the rehabilitation stream support for victims of the massive earthquake in Sichuan, more than 200 Allied Health Professionals joined in the voluntary service. He was awarded the HKSAR Chief Executive's Commendation for Community Service in 2009. Dr Lau has offered valuable advice and teaching support for PolyU's MSc in Manipulative Physiotherapy Programme, being an Adjunct Associate Professor and Professor of Practice. He is currently a member of the Departmental Advisory Committee of Rehabilitation Sciences of PolyU and President of the Rehabilitation Sciences Alumni Association.



Sr Lau Ping-cheung, GBS, JP

Higher Diploma in Quantity Surveying/ 1974 (Hong Kong Polytechnic)

Sr Lau, a veteran, well-respected figure in the field of surveying, is well-known for his longstanding, wide-ranging public duties. Currently a member of the National Committee of the Chinese People's Political Consultative Conference, he has sat on many public boards and government advisory committees looking into pertinent issues from economic development, land and housing, education to integration of Hong Kong with the Mainland. Input from the Hong Kong Coalition of Professional Services co-founded by him in 2001 is often sought for the yearly Policy Address and Budget preparations. Currently a PolyU Council Member, he also serves on the University's Governance Committee and Campus Development Committee, besides having facilitated the establishment of the Federation of PolyU Alumni Associations and raised funds for the PolyU Foundation. His extensive social commitments were rewarded with the Silver Bauhinia Star in 2004, Justice of the Peace in 2016, and the Gold Bauhinia Star in 2017.

Ir Arthur Lee Kam-hung

Higher Diploma in Electronic Engineering/ 1981 (Hong Kong Polytechnic); Master of Science in Engineering Business Management/ 2008 (The Hong Kong Polytechnic University)

Ir Lee is Founder and Chairman of Kolinker Group, one of the leading manufacturers in the quartz crystal industry worldwide. His company has received numerous industrial awards including 2002 and 2011 Hong Kong Awards for Industry. The accomplished industrialist has also been heavily involved in public and educational affairs. Currently he is a Member of Election Committee of 13th National People's Congress of China, Chairman of Kowloon City District Committee (Hung Hom District), Founder Chairman of Kowloon City District Senior Police Call Honorary Presidents Council, Vice President of Foundation Board of Hong Kong Young Industrialists Council (2003 Awardee of Young Industrialist Awards of Hong Kong), and Honorary Life Vice President of PolyU Foundation. He has offered supports to PolyU's industrial research on a continuous basis and established scholarships for students at PolyU. His technical publications are adopted as the de facto standard in the industry, such as his "Direct Impedance Method for Load Resonant Measurement of Crystal" presented in the US Piezoelectric Device Conference and Exhibition in 1999.



Mr Alex Lui Chun-wan

Higher Certificate in Building/ 1964 (Hong Kong Technical College)

Mr Lui, an accomplished architect and city planner, has made substantial contributions to Hong Kong's urban development in the past decades. Named a University Fellow of PolyU in 2017, he is currently Project Director of PolyU's Green Deck project, a community-based initiative that will turn the Cross Harbor Tunnel plaza into a sprawling green, recreational site for public enjoyment. Mr Lui has led many prestigious projects locally and overseas, such as the Boston Logan International Airport Master Plan, the Beijing Henderson Centre and The Hong Kong University of Science and Technology campus. Between 2002 and 2008, he was Senior Advisor to



Hysan Development Company Limited. Having served on a number of professional and public bodies, he is also one of the recipients of the Outstanding BRE Alumni Award 2018 offered by the Department of Building and Real Estate of PolyU. He was a member of the PolyU Council and Chairman of its Campus Development Committee, and is currently a member of the PolyU Court.



Mr Elton Ng Chun-ting

Bachelor of Science in Physiotherapy/ 2000 and Master of Science in Sports Physiotherapy/ 2005 (The Hong Kong Polytechnic University)

Physiotherapist Ng not only has immense talents and stamina, he also has a deep concern for others. As an elite cross-country trail athlete, he has represented Hong Kong in various competitions and won prizes. In 2016, he made a record by becoming the second Hong Konger to scale successfully Mt. Manaslu, the eighth-highest mountain in the world. Having conquered Mount Everest in 2017, he became the second Hong Kong mountaineer who had completed eight expeditions covering the eight highest mountains among seven continents in the world. He was named one of the Ten Outstanding Young Persons (Professionals category) by the Junior Chamber International Hong Kong in 2018, in recognition of his devotion to volunteer services and charitable causes. It is noteworthy that for years he has designed patient rehabilitation plans for the Hong Kong Arthritis and Rheumatism Foundation and acted as team physiotherapist for sports events in different countries. He has also inspired many with his books on his personal journey of overcoming multiple challenges to reach his goals.



Mrs Natalia Seng Sze Ka-mee

Higher Diploma in Company Secretaryship and Administration/ 1979 (Hong Kong Polytechnic)

Mrs Seng, Vice Chairman of Tricor HK and Offshore and Member of Tricor China Management Committee of Tricor Group / Tricor Services Limited,

spearheaded the growth of Company Secretary services in Hong Kong and beyond. She was President of The Hong Kong Institute of Chartered Secretaries (2007-2009) and a Council Member of the Institute of Chartered Secretaries and Administrators in the United Kingdom (2010-2014). In recognition of her contribution to the development of company secretary services and enhancement of corporate governance, Mrs Seng was awarded "The Hong Kong Institute of Chartered Secretaries Prize 2017". Mrs Seng was appointed by the Government a lay Council Member of Hong Kong Institute of Certified Public Accountants (2013-2015) and a Member of the Standing Committee on Company Law Reform (2016-2020).



Mr Dominic Tam Jo-tak

Higher Diploma in Production and Industrial Engineering/ 1977 (Hong Kong Polytechnic)

Mr Tam, Executive Chairman and CEO of Combine Will International Holdings Ltd., demonstrated much passion and entrepreneurial spirit in transforming his toy manufacturing company into a major supplier of industrial moulds, machine tools and other consumer products besides toys. Under his leadership, his company has built a good reputation and has received numerous awards for its contributions to the community, employees' wellness, and green production. Currently the President of the Professional Validation Council of Hong Kong Industries, he held chairmanship at many other industrial associations, including the Hong Kong Diecasting Association (now the Hong Kong Foundry Association) and the Toys Manufacturers' Association of Hong Kong, promoting industrial development and the training of future talents in Hong Kong. He was Chairman of the organising committee for the "Learning Enterprise Award" co-organised by PolyU and PVCHK in 2017.

Mr Marcellus Wong Yui-keung

Mr Wong is Vice Chairman of the Board of Directors of AMTD Group, a comprehensive financial institution group with services coverage worldwide. Having established a stellar career from his days as a young accounting graduate and tax assessor to becoming a partner of PwC, he has been a source of advice for the government on taxation issues. He is currently Chairman of the Advisory Board, Examination Board of CTA Qualifying Examinations, and Tax Policy Committee of the Taxation Institute of Hong Kong. In 2017, his dedication to charitable causes won him the "Asia Social Caring Leadership Award" under the Social Enterprise Research Academy's Social Caring Pledge Scheme. In 2018, he led the AMTD Foundation to jointly establish with PolyU the first university-industry collaborated financial technology (FinTech) centre in Hong Kong — the AMTD FinTech Centre of PolyU Faculty of Business with the aim of transforming Hong Kong into an international and leading FinTech hub.
