PUSA ALERT Issue No. 2 (December 2014)

Item 1 Follow up on the Staffing Exercise of 2013/14

Since the issue of PUSA Alert 1a on 19th September 2014, reporting to you all PUSA's concern about the assessment results of the 2013/14 Staffing Exercise for Academic Staff on contract / regular terms, not much discussion has taken place. With the consensus of the staff members concerned, PUSA has submitted a list of staff members who will be represented in the follow up discussion. PUSA believes that these cases illustrate serious issues concerning the implementation and decision making process of the Staffing exercise. The two lawmakers Fernando CHEUNG and Pik-wan WONG have also approached PUSA for information. PUSA is still waiting to have a direct discussion on this issue with Senior Management.

Item 2 Follow up on policies relating to evaluation of teaching performance

Since early September, PUSA has started a series of email exchanges with Senior Management on the policies relating to evaluation of teaching performance. The policy papers involved are a series of papers developed over the past few years and PUSA is concerned about the evolution of the entire policy and the final outcome. At this moment, PUSA has been told that a campus-wide consultation will take place in early 2015, and we hope that all colleagues involved in both the academic and teaching tracks will follow the development of this issue closely.

Item 3 Follow up on the policy paper concerning the Career Progression and Promotion for Non-academic Staff members

This new policy is going to be an important issue for non-academic staff members of the university community. Meetings have been held with Senior Management over the summer months. PUSA has given feedback about the drafted paper, and we are informed that consultation with staff members will take place before this policy is implemented some time in 2015. Again, PUSA urges all non-academic staff members to keep track of the development of this issue.

Item 4 Memorial service for a beloved staff member

In memory of a staff member from CPA who left us last December, PUSA will place a flower bouquet near the Li Ka Shing Building from 5th December for three days. In addition, a group of Catholic colleagues will organize a mass in memory of the staff member. Details as follows:
