Submission Requirements

 - A scalable graphic in A4 document size (210mm x 297mm) in PNG or PDF format (10Mb maximum). Shortlisted entries are requested to submit the vector PDF format with 300 dpi output resolution or Adobe Illustrator compatible formats at a later stage.
 - Both colour and black/white versions of the logo should be included.
 - A brief description illustrating the design concept.
 - Indicate in the email if you are:
 - PolyU student (Full name, current programme, year of study, student email address)
 - PolyU staff (Full name, department and staff email address)
 - PolyU Alumni (Full name, graduation programme, graduation year, contact email address)

Prize and Award
