CIMA signs agreement with The Hong Kong Polytechnic University to nurture future business leaders in Hong Kong

On successfully completing the programme and fulfilling the practical experience requirements, students earn CIMA© membership in addition to the prestigious CGMA® designation, enhancing their career prospects. CGMA designation holders are in demand from the world's leading companies and offer a route to a varied and fulfilling career, supporting both national and global economies.
