條例實施在即：跨界別研討會凝聚專業力量  
Ordinance Implementation Nears:  
Cross-sector Forum Unites Expertise

《強制舉報虐待兒童條例》（下稱「條例」）將於2026年1月20日正式實施，涵蓋社福、教育及醫療界共25類專業人士，而聖基道作為本港提供最多兒童之家服務名額的社會服務機構，擁有一隊多專業的團隊，專業員工佔全院員工比例達34%。因此，本院早於條例草議階段已成立專責小組，並聯合業界機構向立法會提交意見書，更於2024年年初舉辦研討會，收集業界意見並再次提交立法會，促請政府在修訂條例時回應業界建議。透過持續的跟進及倡議工作，欣見政府於修訂條例時回應了不少業界提出的建議。

The Mandatory Reporting of Child Abuse Ordinance (the Ordinance) will take effect on January 20, 2026, covering 25 professional groups across social welfare, education, and healthcare. As a non-governmental organization in Hong Kong providing the largest number of Small Group Home service for children, our multi-professional team includes a significant ratio that 34% of capacity are registered professionals. From the drafting stage, the Home set up a task force internally and, together with sector partners, collected and submitted views on the Bill to the Legislative Council. In early 2024, the Home organized a Forum to gather frontline feedback and submitted farther recommendations to the legislature. Through continued follow-up and advocacy, we are pleased to see many proposed ideas reflected in the final ordinance.

2025年9月30日，聖基道再次聯同香港理工大學應用社會科學系專業實務及評估中心舉辦「The Law, The Duty, The Action: 《強制舉報虐待兒童條例》下的跨專業實踐 - 「法律解讀 × 實務智慧 × 應對準備」研討會」，內容涵蓋立法初心、條例解讀、強制舉報者指南、跨界實務分享、機構風險應對及真實個案分享，協助各界為條例實施做好準備。聖基道在報名期間向逾千名參加者進行問卷調查，結果顯示七成人回覆自評對條例認識不足，突顯培訓與支援的迫切性。

On September 30, 2025, the Home, together with the Professional Practice and Assessment Centre of the Department of Applied Social Sciences of the Hong Kong Polytechnic University, organized "The Law, The Duty, The Action: Cross-professional Practice under the Mandatory Reporting of Child Abuse Ordinance" Forum. The content of the Forum covered the legislative intent, clause interpretation, Guide for Mandated Reporters, cross-sector practice sharing, institutional risk management, and real-case reflections — supporting stakeholders to prepare for implementation. A survey of over 1,000 registrants found that 70% reckoned themselves lack of the knowledge on the Ordinance, underscoring the urgency of training and support.

令人鼓舞的是，研討會後收回的330份問卷回饋中，高達98.2%參加者認為是次活動有助增加他們對條例的認識。至於參加者對條例的認知程度平均分，亦由會前的3.13，提升至會後的4.08（五分滿分），增加了30.4%；而表示對條例只有一般或以下認知程度的參加者則由會前的74%，大幅下降至會後的16.7%，是次研討會對業界人士的裨益顯然而見。

Encouragingly, among 330 replies to the post-event questionnaire, 98.2% of respondents agreed that the Forum enhanced their understanding of the Ordinance. The average self-rated knowledge of the Ordinance rose from 3.13 before to 4.08 (out of 5) after the Forum — an increase of 30.4%. The proportion rating their knowledge as average or below dropped sharply from 74% pre-event to 16.7% post-event, underscoring clear benefits for respondents.
