Teaching/Learning Methodology	This subject consists of lectures designed to enhance students' critical thinking and analytical abilities through an interactive approach that encourages students to engage in discussions and debates on ageing, family and related issues. Students are also required to work on a group project and deliver a group presentation for it, through which they learn to develop knowledge in specific areas and articulate their arguments logically and systematically. Blended learning approach might be used where appropriate.

Group presentations and participation are essential for students to learn in an interactive manner and in a group setting. They are required to have in-depth explorations on some issues related to ageing, family and society, apply theories and techniques learnt from lectures to the analysis of the issues concerned. Both efforts and originality are key criteria for assessing students' performance. Students are required to submit an individual term paper of 3,000 to 4,000 words including title page, executive summary, tables, figures, and references. The paper has to be presented clearly in an academically relevant approach with evidence-based analytical reasoning. Whether students are able to apply theories and concepts learned from this subject in the analysis will be assessed.
