It should also prepare students for more in-depth study of the public sector.

Subject Synopsis/ Indicative Syllabus

This course is to introduce students to a macro perspective of administration of government and the public sector. It provides an overview of major concepts and issues involved in the study of government and public administration.

- Overview, key concepts and approaches
- Contexts and environment of government and public administration

2. Part B. The Fundamentals

- Need for and limits to government action
- Instruments and processes of public administration
- The classical public administration model
- Checks and balances, and accountability

3. Part C. New Trends and The Enduring Values

- New public management
- Performance management: an assessment
- Ethics, sense of vocation and public administration
- Critical issues in public administration
- Case studies

Teaching/Learning Methodology

Concepts and theories of government and public administration will be given in lectures designed for student-center and problem-based learning. This will include case studies of current issues and government experiences to illustrate how major theories and approaches could be used for critical analyses. Students are expected to demonstrate their knowledge and communication ability in case studies on government administration and engage in debates of their own readings on government and administrative processes.

Explanation of the appropriateness of the assessment methods in assessing the intended learning outcomes:

Seminar Attendence and Participation:

Students are expected to discuss in groups on their critical views on selected government administrative issues to demonstrate how much they have understood the processes and mechanisms of government and public administration. They are

expected to use case materials to illustrate how they could apply the theories and concepts they have learned in lectures with a PowerPoint presentation while generating genuine debates and discussions. This exercise will show how well they have learned and how effective they are as communicators.

Written Assignment:

Students will write an individual assignment based on their case studies. In this exercise, students can demonstrate their information literacy and communication skills, particularly in terms of organization, coherence and clarity.

Examination:

Students will sit for a final examination which will allow them to review and examine more systematically the important theories, approaches and cases they have learned from the subject.
