<p>Teaching/Learning Methodology</p>	<p>Students are required to carry out a range of specific tasks assigned in a group or individual setting in private, public or quasi-public organizations including research centres in local universities or overseas organizations under close supervision and guidance by supervisors throughout the attachment period to develop a sound appreciation of the responsibility, ethics, standards and values normally expected of practitioners working in the fields of social policy and social entrepreneurship.</p> <p>In addition, in preparing students for their attachment, they are required to attend the Attachment Workshop prior to their attachment. The Workshop is designed to enhance their competence in completing policy and administrative tasks in social policy and social enterprise settings.</p>
