Objectives	<p>The issue of violence in intimate relationships is examined through multiple lenses. An introduction to the history of family violence, theories and current research on the etiology of violence in intimate relationships, interventions and prevention models to addressing this worldwide problem will be discussed.</p> <p>The purpose of this course is for students to gain the knowledge and skills necessary to understand the dynamics of violence in intimate relationships, to conduct clinical assessments, and to identify appropriate intervention strategies.</p>
