Objectives	This subject focuses on professional practice involving the dynamic and interactive processes of engagement, assessment, intervention, and evaluation at multiple levels. Social workers are expected to have the knowledge and skills to practice with individuals, families, groups, organizations, and communities. This subject aims to equip students with the basic abilities to recognize and select appropriate intervention theories to inform these practice processes with innovation. In addition, this subject will also touch upon the ethical issues, dilemmas and politics of social work intervention practice.

- Moral-political-cultural nature of social work practice
- Integration of theory and practice: the role of reflection and practice knowledge in integration of theory and practice
- Innovation in practice and intervention

Teaching/Learning Methodology

In addition to lectures conducted by the subject teacher, self-reflection exercises, audio-visual materials, simulation games, and demonstration will be used to facilitate classroom teaching. Web-based Learning is also used to facilitate student learning. Seminars will be used to enable the students to discuss practice issues related to the knowledge learned in the class. A small group of around 4 students will organize discussion, case studies or debates among their fellow classmates. In seminar sessions, the subject teacher will serve as a consultant and a resource person.
