<b>Objectives</b>	<p>The subject aims to equip the students with basic legal knowledge relevant to social work practice and possible issues involved. They should be able to understand the general legal principles in selected areas and apply them to problems or cases. Moreover, they should be able to understand the legal rights and obligations of the social workers and their service users. This understanding can facilitate both parties to assert their legal rights and discharge their legal obligations with the mobilization of suitable support. Students should not lose sight of the primary responsibility of promoting social betterment with the knowledge of the legal framework of practice.</p>
