Teaching/Learning Methodology	<p>Students are expected to be active learners in the class. They will be provided with the essential perspectives to look at the developmental tasks of children and adolescents in Hong Kong, and the analysis and solutions to students' problems and mental health issues in both primary and secondary schools. Built into the lectures are case discussion to enable students' participation and contribution. With the benefits of the knowledge gained in the subject, students are also required to choose a topic within the boundary of the subject and make a presentation of it in the seminar. Hence, students' participation in both lectures and seminars, and efforts paid will be an integral part of the teaching and learning strategy.</p>
