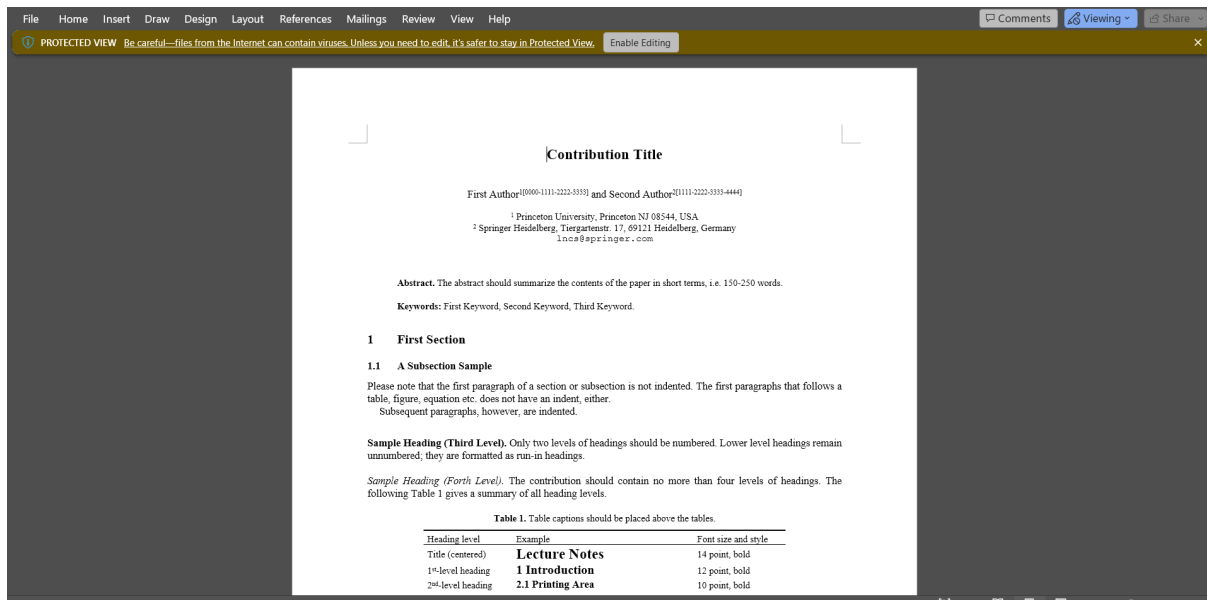


Explaining notes to help authors prepare the WCFS 2024 full paper

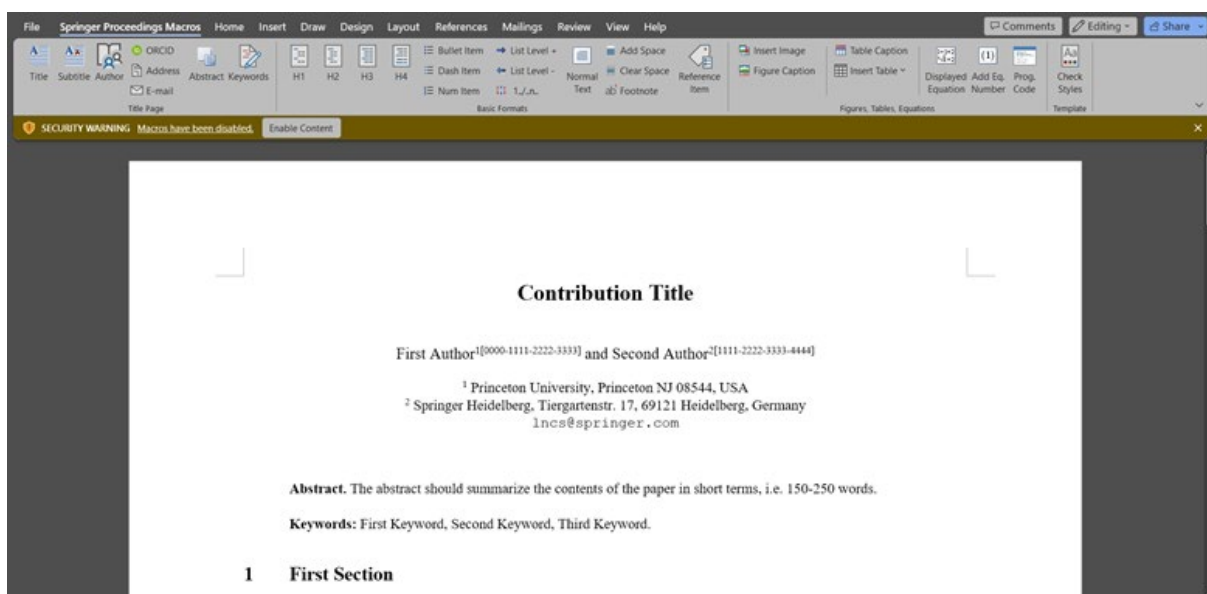

Opening and saving the file.

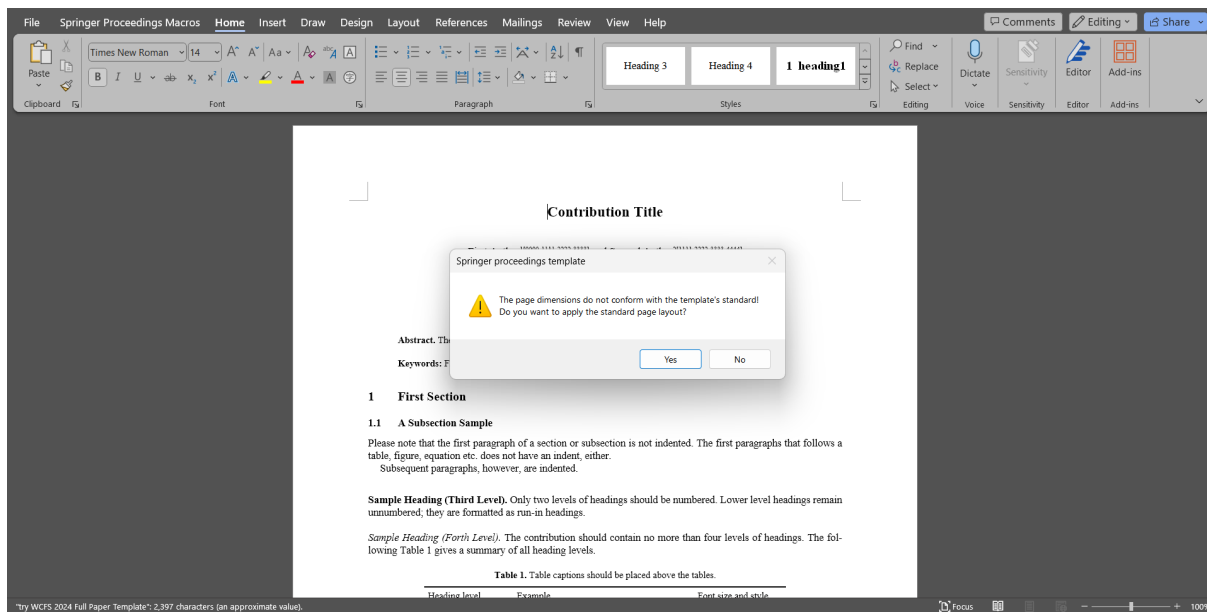
When downloading the template from WCFS 2024 website, a security question may come up (see below). Please click “Enable editing”.



When opening the template file, if you see a Security Warning question shown below, click “Enable content”.



If you see the following question about page dimensions, click No, because the margin in standard layout is too large. By clicking No to this question, the margin will be 1 inch for Top, Bottom, Left and Right.



Then save the file to the following name system:

WCFS2024-X-First Name-Family Name

where “WCFS2024-X” is your article number, and “First Name” and “Family Name” are for the corresponding author.

Some detailed notes about the use of the template are provided in coming three pages.

Please replace with the title of your paper

Abstract. The abstract should summarize the contents of the paper in short terms, i.e. 150-250 words.

Keywords: First Keyword, Second Keyword, Third Keyword.

1 First Section

Authors are encouraged to copy-paste these headings then edit. Heading numbers will be automatically updated.

1.1 A Subsection Sample

Please note that the first paragraph of a section or subsection is not indented. The first paragraphs that follows a table, figure, equation etc. does not have an indent, either.

Subsequent paragraphs, however, are indented.

Sample Heading (Third Level). Only two levels of headings should be numbered. Lower level headings remain unnumbered; they are formatted as run-in headings.

Sample Heading (Forth Level). The contribution should contain no more than four levels of headings. The following Table 1 gives a summary of all heading levels.

Only the first letter in caption is capitalized.

Bold

Table 1. Table captions should be placed above the tables.

Heading level	Example	Font size and style
Title (centered)	Lecture Notes	14 point, bold
1 st -level heading	1 Introduction	12 point, bold
2 nd -level heading	2.1 Printing Area	10 point, bold
3 rd -level heading	Run-in Heading in Bold. Text follows	10 point, bold
4 th -level heading	<i>Lowest Level Heading.</i> Text follows	10 point, italic

Displayed equations are centered and set on a separate line.

Please **DO NOT** use pictures. Please use MS Word Equations Editor or MathType to enter equations.

Equations should be numbered consecutively.

2.1 A Subsection Sample

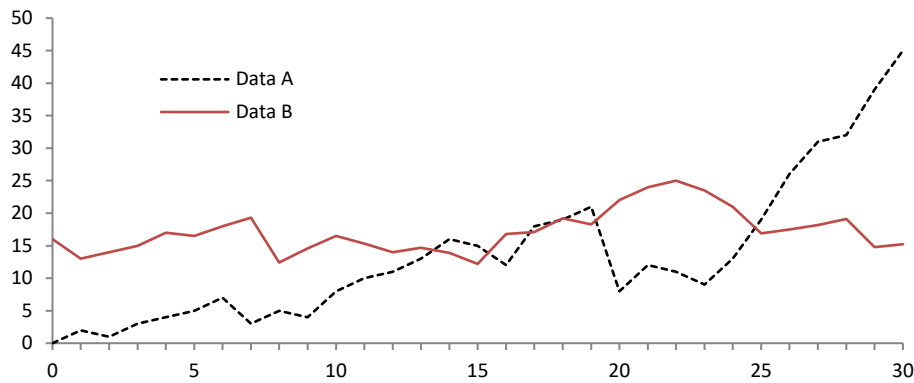


Fig. 1. A figure caption is always placed below the illustration. Short captions are centered, while long ones are justified. The macro button chooses the correct format automatically.

Please try to avoid rasterized images for line-art diagrams and schemas. Whenever possible, use vector graphics instead (see Fig. 1).

Bold. Fig., rather than Figure.

Only the first letter in caption is capitalized

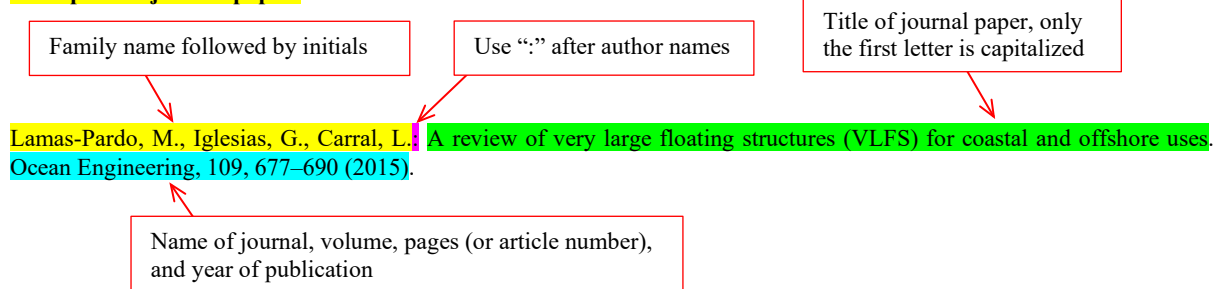
3.1 A Subsection Sample

For citations of references, we prefer the use of square brackets and consecutive numbers. Citations using labels or the author/year convention are also acceptable. The following bibliography provides a sample reference list with entries for journal articles [1], an LNCS chapter [2], a book [3], proceedings without editors [4], as well as a URL [5].

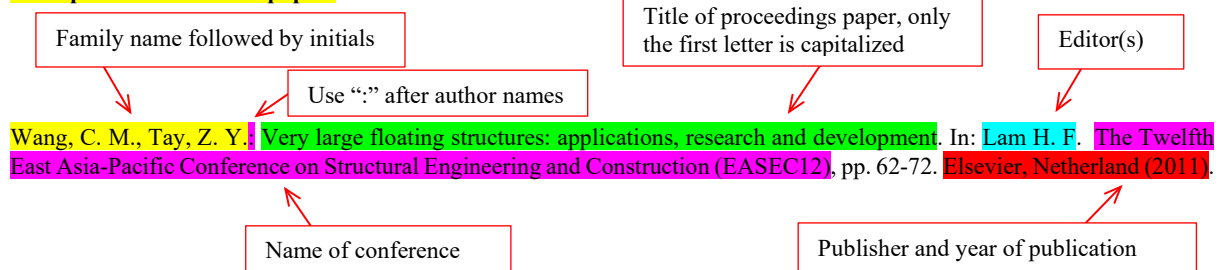

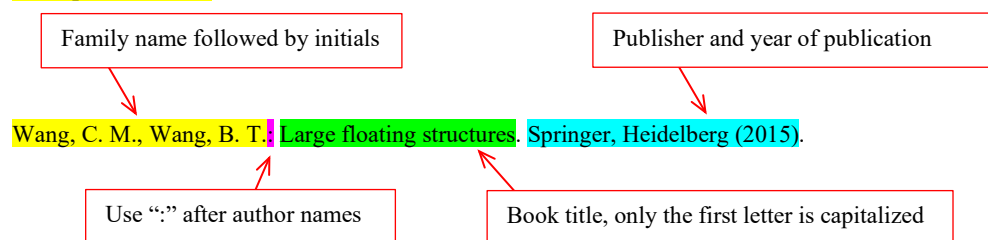
