Dear Colleagues

Further to my email of 13 July and the briefing sessions conducted last week on the implementation of the Online Tutorial on Academic Integrity, the Working Group on Promoting Academic Integrity have discussed with me some concerns and suggestions regarding the introduction of this compulsory requirement for completion of the Online Tutorial. A major concern relates to difficulties in identifying a suitable subject other than Freshman Seminar for the required completion of the Tutorial.

After further considerations for ways to address the concern within the scope of the policy, I am pleased to inform you that modifications have been made to the implementation plan for the 3-year undergraduate and higher diploma programmes in 2012/13. The following details the method for implementing the Online Tutorial completion requirement for the coming academic year (2012/13):

1. In <u>full-time 4-year undergraduate programmes</u>, the Online Tutorial is a completion requirement in the *Freshman Seminar* subject. No grade or weighting will be given to this requirement component. However, students who have not completed the Tutorial before the deadline will fail the subject. 2. In <u>full-time 3-year undergraduate and higher diploma programmes</u>, discretion can be exercised by Departments/programmes on: EITHER (a) making the Online Tutorial a compulsory requirement for completing a specified subject identified to be suitable, as in the 4-year undergraduate programmes, OR (b) making the Online Tutorial available to the students and encouraging them to complete it on a <u>voluntary</u> basis.

Approval for the change to subject description

As regards the other major concern about approval to the addition of the Online Tutorial completion requirement in a selected subject, the Academic Secretariat has been consulted. Such changes to the design and delivery of subjects would normally be considered as minor changes, and approval beyond the subject level would <u>not</u> be necessary. It is important, as with all other requirements in any subject, that the Online Tutorial as a compulsory requirement for passing the selected subject be clearly communicated to students at the beginning of the course. If, however, Faculties/Departments/Schools prefer to seek approval from the Undergraduate Programme Committees and/or Faculty/School Boards for incorporating the Tutorial completion requirement in the chosen subjects, they should promptly follow this up with the relevant committees. Faculty Deans/Heads of Departments/Chairs of Departmental Undergraduate Programme Committees are kindly requested to facilitate a speedy approval of the changes.

Provision of subject information for enrolment and completion reports

To facilitate enrolment of students to the Online Tutorial, and provision of student completion reports to Subject Leaders, could Faculties/Departments/Schools complete the attached forms and send them to <u>ecdebbie@inet.polyu.edu.hk</u> by 17 August 2012. The two forms are as follows:

- ... Form A for Freshman Seminars in 4-year undergraduate programmes This form should be completed by the Faculty Secretary, in collaboration with the Subject Leader of *Freshman Seminar* for the Broad Discipline(s).
- ... Form B for full-time 3-year undergraduate and higher diploma programmes This form should be completed by Departments to provide information about the selected subject with the compulsory tutorial completion requirement.

I hope you will find the other attachments useful to your preparation of the description and assessment schedule of the selected subject containing the Online Tutorial:
