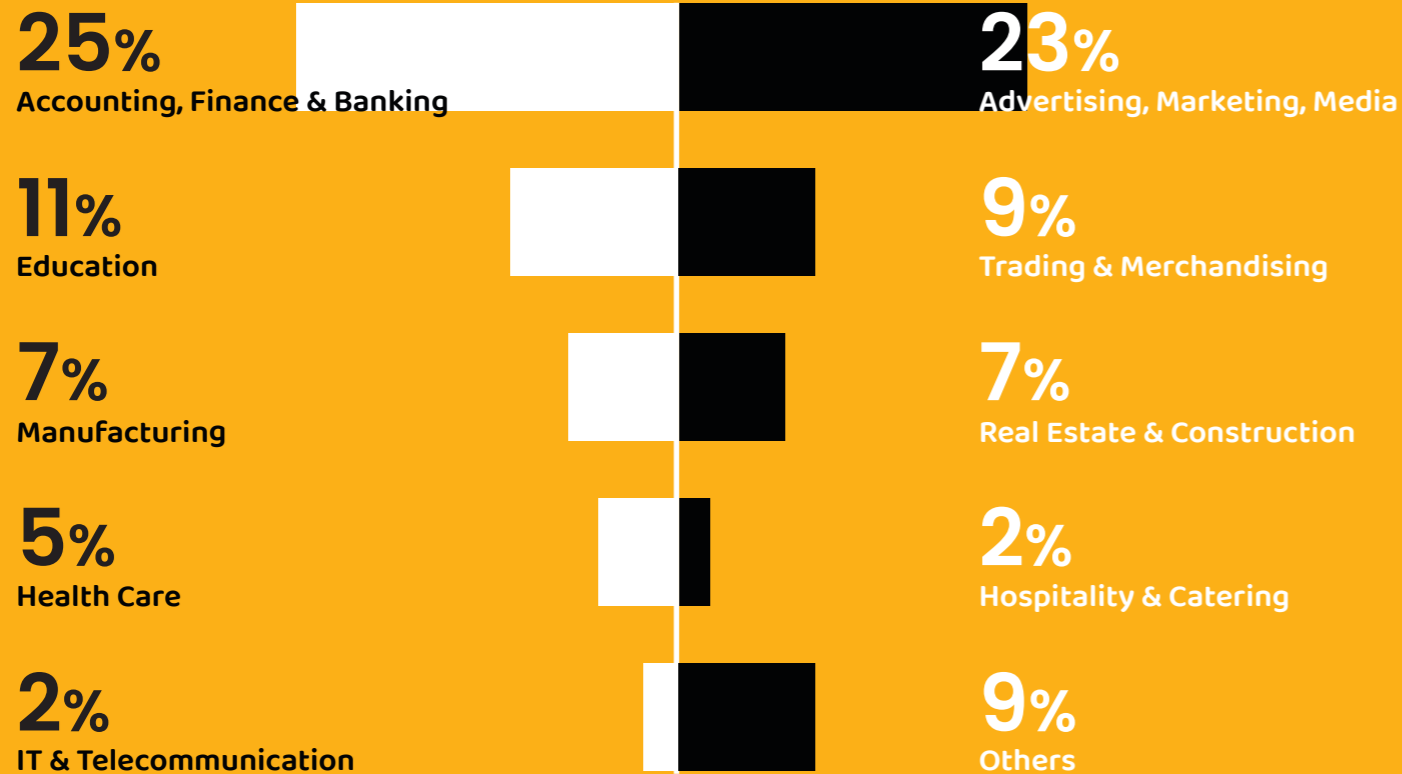

Post-MBA Placements



Immigration Arrangement for Non-Local Graduates (IANG)*

Non-local students who have completed a full-time locally accredited programme at the undergraduate level or above in Hong Kong are eligible to stay in Hong Kong for a period of 24 months under IANG without any additional conditions of stay. They are free to work or study in Hong Kong without seeking prior approval from the Immigration Department.

These eligibility criteria may change from time to time without prior notice. Please visit the Immigration Department website for up-to-date information: www.immd.gov.hk/eng/services/visas/IANG.html.

No Objection Letter (NOL)* & Part-time employment

Non-local students who have been approved to study a full-time locally accredited postgraduate programme in Hong Kong will receive an NOL from the Immigration Department with their student visa. This letter allows them to take up part-time employment / summer jobs. From 1 Nov 2023, students are temporarily exempted from the restrictions on the number of working hours and the job location. This arrangement will continue until 31 Oct 2025.

*Please note that applications for IANG and NOL are subject to approval by the Immigration Department of the HKSAR Government.

2025-26 Admissions

Requirements

- A Bachelor's degree, postgraduate degree, or postgraduate diploma in any area, or an equivalent professional qualification
- At least 2 years of postgraduate full-time work experience
- Proficiency in English*
- Exceptionally, applicants with post-secondary qualifications and at least 8 years of full-time work experience, and proficiency in English, will also be considered on a case-by-case basis.

Tuition Fee

HK\$506, 220
(for local and non-local students)

Scholarships

- Merit-based scholarships will be automatically considered for all applicants
- Applicants will be evaluated based on a holistic set of criteria, including academic and professional qualifications, career background, interview performance, and potential contribution to the programme
- Scholarship results will be released shortly after the issuance of admission offer

*If an applicant is not a native English speaker and his/her Bachelor's Degree or equivalent qualification is awarded by institutions where the medium of instruction is not English, the applicant is expected to provide one of the following proficiency test results (taken in a single sitting within 2 years):

- TOEFL score of 80 or above; OR
- IELTS Overall Band score of 6.0 or above

Remarks: TOEFL iBT Home Edition, the IELTS Online and IELTS indicator test results will not be considered for meeting the English language Requirements for taught programmes.



Application Process

Prepare Supporting Documents

Prepare the following documents before proceeding to Step 2:

- Certificate and transcript of academic qualification(s)
- Employment proof for full-time work experience
- Official IELTS / TOEFL score report*
- Optional: Curriculum vitae, referee report(s), official GMAT / GRE report
