The individual paper should normally be around 3,000 – 5,000 words.					
Teaching/Learning Methodology	The student who chooses to do an independent study will work directly with a faculty member who agrees to act as an advisor. The staff member will be an expert in the agreed area of study and will provide the student with individualized instruction. In conjunction with the staff member, the student is expected to produce one piece of work that is rigorous and of high quality.
