



# **Bernadette M. WATSON**

### **Professor, Department of English**



### Faculty Awards for Outstanding Performance/Achievement in Research and Scholarly Activities (Individual) 2019/20

Prof. Watson has an impressive number of high-impact publications. These include 63 articles in top international peer-reviewed journals, three edited books and 31 book chapters, all published by international publishers, including a number of chapters in handbooks in the disciplines of Communication Science and Applied Linguistics. In the last five years, Prof. Watson has published 37 journal articles and 13 book chapters. She has had 1,541 citations since 2015.

Prof. Watson's work has received recognition in Hong Kong and worldwide. She is a Fellow of the International Association of Language and Social Psychology (IALSP), from which she was awarded a life-time achievement award in 2016 for her research in health communication. She is a past President (and recent executive member) of IALSP, and she was a Board member of the International Communication Association (ICA) and has been Chair of a number of ICA committees. She has held the position of an executive member of the Australian Psychological Society within the Queensland Health Psychology Branch and is a Fellow of the Hong Kong Academy of Humanities.

As a world leader in the field of language

and social psychology (LSP) and health research, Prof. Watson's contribution to this field has been to apply and refine theory from a LSP perspective. Her research focuses on patient and health professional interactions as well as on the interactions between multi-disciplinary health teams. Prof. Watson has acquired over eight million Australian dollars (almost HK\$50 million) in competitive external research funding. Her research areas include clinical handover, maternity care, adverse patient events and problems in communication between health professionals and patients when English is not a first language. Most importantly her research is designed to have impact on health research and in the community because it is aimed to influence the workplace practice and communication of clinicians. She adopts this approach because of her belief that work in this field can make a practical difference to people's lives and health outcomes. She has established strong links with four hospitals in Hong Kong and has conducted in-depth research with clinicians on quality patient care and communication in Hong Kong hospitals. To this end she is about to commence research with clinicians to assist them in managing the effects of the recent Covid-19 pandemic in respect to their psychosocial health and wellbeing.

Prof. Watson is also Director of the International Research Centre for the Advancement of Health Communication (IRCAHC) and has just completed co-editing a book within the Humanities in Asia series that brings together a range of clinicians and researchers from Asia and the West and emphasises the healthcare in Asia and its synergies with the West. She has also formalised a research partnership between IRCAHC and the Health@Business Research Network at UNSW Business School, UNSW Sydney. This collaboration signals the beginning of important research initiatives which include the submission of joint research proposals to competitive external funding sources, the building of a joint research publication profile to international peer reviewed journals on health-related topics.

### Faculty Awards for Outstanding Performance/Achievement in Teaching (Individual) 2019/20

Dr Tse has managed to maintain a very high SFQ scores in the past 10 years (2019/20: 4.7; 10-year average: 4.5) despite a heavy teaching load and she always receives very positive feedback from students and supervisees. She is actively involved in subject development, and is a keen proposer of CAR subjects.

In 2019, Dr Tse received the LTC Overseas Scholarship and visited Yale University for two months. This project enabled her to contribute innovative teaching practices to PolyU and to the wider community, and to connect PolyU to a world-renowned tertiary institution. Her newly approved CAR subject in 2020, for instance, adopts the "teach-everywhere" and the "change-classroom-shape" pedagogical concepts applied in the classes she observed at Yale. The study visit has also inspired her to regularly bring her students off-campus to engage in live performances, art events and educational dialogues with professional writers in public venues, complemented by in-class preparation and follow-ups.

Dr Tse is also actively involved in knowledge transfer on teaching and learning. She was invited to visit two VTC/IVE campuses to give advice on how the English learning of moderate/low achievers could be enhanced by interactive use of classroom space. She has also given three presentations about multimodal teaching strategies based on the Yale project at international education conferences. The Centre for Learning Enhancement and Research at CUHK has recently expressed interest in future collaboration. Dr Tse's long-term advisory role in HKEAA for subject development and examination design of HKDSE Literature in English, as well as her recurrent appointment as External Examiner of various English modules for the English Centre of VTC/IVE, also bear witness to her dedication to teaching. She also regularly serves as an instructor in teacher training programmes in Hong Kong and the Chinese mainland.

Since the completion of her PhD in 2018, Dr Tse has contributed regularly to The Literary Encyclopedia, a scholarly and pedagogical digital platform providing teaching- and learneroriented facilities. Her continuous communication with Yale faculty about learning spaces will be turned into pedagogically-focused publications.

In terms of teaching management and education leadership, Dr Tse was appointed Programme Leader of the Department's BA programme in English for Business and Professional Communication. She was also a member of the Departmental Learning & Teaching Committee, and was always actively engaged in local (e.g. ENGL Coordinator of Summer PLACE camp) and overseas (e.g. Beijing, Kazakhstan) promotion.

### Faculty Awards for Outstanding Performance/Achievement in Teaching (Team) 2019/20

The English Language Centre (ELC) Service-Learning (SL) Team develops, administers and delivers both onshore and offshore credit-bearing SL subjects. Ever since its inception with the ELC's first SL subject in 2011, the Team has experienced many breakthroughs, including:

- Extension of service location to Hong Kong, the Chinese Mainland, Taiwan, Cambodia and Myanmar in the coming future
- Expansion of service scopes from teaching English to primary school children, to teacher training, and making digital documentaries for NGO partners
- Increase of beneficiary numbers to an average of 2,000 school children per academic year

The Team has developed and delivered two subjects, ELC2S02 Serving the Community through Teaching English and ELC2S03 Persuasive Digital Storytelling. Both subjects train students in the skills of giving presentations, persuasion and storytelling, thus better enabling them to deliver high-quality service overseas to those in need. The subjects employ a learner-centred approach to the classroom and a highly interactive delivery style, both of which have been received favourably by students and recognised as having an impact on their learning. The longstanding subject ELC2S02 has gained popularity among students. Every year about 300 students participate in the pre-selection process to compete for 80 places in the Semester 2 offering.

The Team demonstrates educational leadership through its efforts in advancing national and international engagement, embracing diversity and promoting lifelong learning. Many of the SL subjects that the Team has developed include an outbound service component putting students into direct contact with the rest of the world and with diverse peoples with whom they are unfamiliar. The Team supplements this contact with critical thinking and confidence-building exercises — both within the classroom and at various service points — so that students enhance their lifelong learning capabilities and develop a sense of global citizenship.

The Team has developed innovative pedagogies for the subject, researching their effectiveness and sharing their findings with others. The Team became one of the first in ELC to enact a flipped classroom approach when they developed a series of learning videos for one of their subjects in 2017. The transition to full-time online teaching in 2019-20 was as a result relatively easy for the Team and ended up providing students with better online



instruction and teachers with more effective lesson plans during this challenging time. With an aim of sharing this flipped classroom approach with both colleagues and the wider education community, the Team researched its effectiveness and the perceptions of both students and teachers. Research findings were presented at local and international conferences.

PolyU's most recent Strategic Plan lists *Quality of Students Experience of Teaching and Learning, Knowledge Transfer and Wider Engagement*, and *Enhanced Internationalisation and Engaging the Nation* as characterising the University's vision for the next five years, the Team's efforts in teaching, subject management and educational leadership help ensure that the success in these domain.

### Louise CUMMINGS Professor, Department of English



### Dean's Award for Research Excellence (DARE) 2019/20

Prof. Cummings' research spans two linguistics disciplines (pragmatics and clinical linguistics) and two health disciplines (speech-language pathology and public health). The focus is on the cognitive basis of pragmatic disorders, particularly in adults with neurodegenerative disorders, and on public health reasoning by experts and lay people. Prof. Cummings is the single author and editor of 18 volumes (14 as author and 4 as editor). Of these volumes, eights are published by Cambridge University Press and five by Springer. The remaining five are published by Palgrave Macmillan, Routledge and Edinburgh University Press. Several of her books have foreign language translations (Turkish, Arabic, Italian and Indonesian).

Prof. Cummings is also the single author of 41 journal articles and 19 book chapters. Chapters have appeared in the *Oxford Handbook* of *Pragmatics, Handbook of Language and*  *Speech Disorders* (Wiley-Blackwell), and the *Routledge Handbook of Pragmatics*. She is also the author of articles on Clinical Linguistics in the *Oxford Research Encyclopedia of Linguistics* (2017) and *Oxford Bibliographies in Linguistics* (2014). She is the Editor of the *Routledge Research in Speech-Language Pathology, Cambridge Elements in Health Communication* and Consulting Editor of the series *Perspectives in Pragmatics, Philosophy & Psychology.* She has a total of 2,430 citations, 1,439 since 2016, and a h-index of 24.

Prof. Cummings is a member of the Royal College of Speech and Language Therapists and the Health & Care Professions Council, both in the UK, and a Fellow of the Hong Kong Academy of the Humanities. She has delivered talks and keynote addresses in universities in the HK and overseas, including a keynote address at the International Pragmatics Conference 2019 held at PolyU.

Since the approval of CLC's demerger from CBS in July 2019 as an independent academic unit by Senate on 28 March 2019, Olivia as the top administrative staff in CLC has been taking an overarching role to assist the designated Director, lead the whole administrative team and monitor the IT team to ensure smooth transition of the entire process.

Olivia's major contributions and achievements in regard to the demerger of CLC range from space separation, budgeting and staffing management to establishment of the Centre's management frameworks and subject administration.

After the demerger of CLC from CBS, Olivia has quickly assumed and adapted to the duties and the roles used to be undertaken and played by the SEO in the days under CBS and become solely responsible for the administration of the Centre with a considerable size of staff.
