## **Group Travel Insurance for Students**

The University has arranged a travel insurance policy for all registered students going overseas for activities or internships endorsed by the University outside Hong Kong. Details are as follows:

# Eligibility

- a) All registered students, including but not limited to, undergraduates, postgraduates, research students, exchange students etc., going overseas for activities approved/ endorsed/arranged by the University.
- b) For non-local students choose to stay in their home country after endorsed project, they will not be covered from the date of completion of the endorsed project.
- c) If both your place of departure and return are outside Hong Kong, you are NOT eligible to join this insurance plan.

  - Name of the traveler
  - Period of travel
  - Itinerary
- b) Kindly note that the processing time for issuing the travel insurance certificate around one week upon receipt of the required information by the corresponding department.

### **Claim Procedure**

- a) Student should submit their claim together with scanned copies/photos of supporting document, including the signed authorization letter, to insurer, Chubb Insurance Hong Kong Limited ("Chubb"), via their Online Insurance Claim platform directly (www.chubbclaims.com.hk) not later than 90 days from the date of accident. c) For trip commencing between 1 July 2024 to 30 June 2025, please submit their claim form together with scanned copies/photos of supporting document as listed in page 4 of the claim form, to insurer, AXA General Insurance Hong Kong Limited ("AXA"), via email to (travel.claims@axa.com.hk) not later than 90 days from the date of accident.
