CALL FOR PAPERS

The theme of APTA 2010 addresses and recognizes a growing and important issue among many regional tourism destinations in the Asia Pacific Region and in all parts of the world: the pressure to compete or collaborate. Sub-themes and other related areas comprising this year's presentation sessions encompass, but not limited to, the following:

- Destination competitiveness
- Regional tourism cooperation
- Industry collaborative or competitive networks and relationships
- Emerging collaborative or competitive frameworks in tourism activities
- Competition in tourism product development
- The role of regional grouping and regional tourism associations
- Private and public competition and collaboration in tourism programs

In addition, submissions that link the general theme with following subject areas in tourism and hospitality are also welcome:

- Emerging Tourism and Hospitality Trends
- Tourism between Partitioned States
- IT & Internet aspects of tourism/hospitality / food service
- Human resources development & educational issues in industry
- Hospitality & Tourism Education
- Marketing & promotion of tourism/hospitality / food service
- The convention & exhibition industry in Asia Pacific Region
- Community tourism development & rural/farm tourism

The conference will focus on a broad range of topics related to research in tourism and hospitality. The conference invites papers on either completed research for standing presentation or a preliminary report for poster session.

SUBMISSION GUIDELINES

We invite authors to submit original and unpublished papers which will be subject to a double-blind review process. Authors can either submit an extended abstract or full paper for the review process. Papers published in the conference proceedings will be denoted either as being accepted on the basis of an extended abstract or full paper submission.

Submisson for Review

Three-page abstracts (typed single-spaced) of papers(or full papers) should be submitted for the final selection process. Indicate the author's name and affiliation only on the cover page of the abstract and they should not be indicated anywhere in the abstract. Submit abstract or full papers for review by email to the Director of Paper Review Committee, Dr. Yeong-Hyeon Hwang (dryeong@dau.ac.kr).

- Due date for abstract submission: March 31, 2010.
- Evaluation of abstracts and communication with authors: April 30, 2010.

| Important |

In order for any abstracts or full papers to be eligible to review process, it should conform to details of format guidelines of submission which is available from the APTA website (www.APTA.asia). Once the paper is accepted, at least one of authors must register for and present the paper at the conference.

Submisson for Publication

Once paper is accepted an extended abstract (three pages) and a full paper submission is allowed for publication.

- Due date for manuscript submission for publication: May 31, 2010.
- Papers submitted after the due date will not be included in the proceedings.

PUBLICATION PLAN

Accepted papers will be published in an edited conference proceedings in electronic format with an ISSN number prior to the conference.

BEST PAPERS

Best papers will be competitively selected and authors will be acknowledged with a certificate.
