**(A) Design a Research and Development (R&D) documentation system for Innovation and Solution LAB (ISLAB) of the Hong Kong Police Force**

ISLAB is a newly set up unit of which the charter is to research on emergent technologies and to develop prototypes for enhancing efficiency of operations of police works. The student of the WIE programme will be assigned to design a documentation system for ISLAB to record the R&D product development processes and results including workflow, lessons learnt, prototypes, design, blueprint and programming code.

**(B) Propose utilization of technologies and improvement of workflow of catering services for large scale police operations**

Food and beverage will be ordered and distributed to large amounts of frontline staff involved in pro-longed major operations on the ground. The student of the WIE programme will be assigned to propose ways to streamline the workflow and application of technologies to enhance the operational efficiency, food safety and hygiene; and to minimise wastage in the logistic process.

**(C) Modify inventory checking system**

It is proposed to use Radio Frequency Identification (RFID) scanners and tags to monitor the inventory of police stations. Currently, the system can only check the quantities of inventory but cannot automatically update the inventory records in the checking in and out process. The student of the WIE programme will be assigned to plan for modifying the existing inventory checking system with the hardware required and to design the user interface for the checking in and out functions.

**(D) Propose business process re-engineering and utilization of Internet of Things (IoT) technology in report room operation**

The student of the WIE will be assigned to the conduct research on field, such as report room and propose re-engineering of business processes and the adoption of IoT technology in order to enhance the operational efficiency.
