Shipping Research Ranking

Researchers at PolyU have made outstanding contributions to shipping research. According to Thomson Reuters' *ISI Web of Science*, PolyU tops the list among the world's leading shipping schools in shipping research, in terms of published papers in SSCI journals over the past three years.

The report shows that a total of 470 shipping articles were published in the Transportation category during 2015-2017, among which 38 papers were produced by PolyU. PolyU came first in the world ranking.






1st conference of the Yangtze River Research and Innovation Belt (Y-RIB)




Two-day Course on Practical Considerations in Arbitration

Recognition of Prior Learning (RPL) for the Import and Export Industry





The Recognition of Prior Learning (RPL) mechanism for the Import and Export industry was launched to enable practitioners to receive formal recognition of the knowledge, skills and experience already acquired at the workplace. The Shipping Research Centre has been appointed by the Education Bureau of the HKSAR Government since September 2015 as the sole Assessment Agency of RPL for the import and export industry in Hong Kong. On 31 August 2018, the three-year appointment has finished and HKU SPACE is the newly appointed assessment agency.
