## **Shipping Research Ranking**

Researchers at PolyU have made outstanding contributions to shipping research. According to Thomson Reuters' ISI Web of Science, PolyU tops the list among the world's leading shipping schools in shipping research, in terms of published papers in SSCI journals over the past three years.

The report shows that a total of 638 shipping articles were published in the Transportation category during 2018-2020, among which 57 papers were produced by PolyU's colleagues. PolyU came first in the world ranking.



## **Research Funding**



## Knowledge Transfer Forum on Port Collaboration in Greater Bay Area



Dr Lun introduced the advantages of business environment and operations in Hong Kong, and the challenges facing it. She also discussed the possible collaboration in the regional logistics system within GBA.

## **Belt and Road Initiative (BRI) Conference 2020**

Dr Venus Lun was invited to be the keynote speaker for the Belt and Road Initiative (BRI) Conference 2020 on "Strategizing for Mutual Gains Through BRI" taken place on 11 December 2020. Dr Lun gave a speech on "Connectivity and Trade Relativity", discussing the impact of shipping connectivity and trade flows. She presented her study with UN showing that shipping connectivity is positively correlated with both intra-trade and extra-trade, where intra-trade mediates the relationship between shipping connectivity and extra-trade.

## **AIS Big Data Hackathon, United Nations**

Dr Dong Yang and his team members from Tsinghua University received the 3rd place in the AIS Hackathon on the UN Global Platform, organised by the United Nations. The team focused on key indicators of port performance.
