

Shipping Research Ranking

Researchers at PolyU have made outstanding contributions to shipping research. According to Thomson Reuters' ISI Web of Science, PolyU tops the list among the world's leading shipping schools in shipping research, in terms of published papers in SSCI journals over the past three years.

The report shows that a total of 638 shipping articles were published in the Transportation category during 2018-2020, among which 57 papers were produced by PolyU's colleagues. PolyU came first in the world ranking.



Transport Policy Special Issue



Knowledge Transfer Forum on COVID-19 Impact on Shipping Industry

Three distinguished speakers-Mr. Roberto Giannetta, Prof. Theo Notteboom and Dr. Dong Yang were invited to present their recent studies concerning COVID-19 and the shipping industry. The forum attracted many

researchers, students and industry practitioners to communicate, discuss and share views on the impacts of COVID-19 on the shipping industry.





Big Data Application in Shipping, Wuhan University of Technology

Dr. Dong Yang delivered a research speech on the development of automatic identification system's (AIS) application in maritime research at Wuhan University of Technology on 29 March 2021. He firstly reviewed and summarized the development of AIS, then elaborated AIS's application in two circumstances: port operation and shipping company's management.





APRO Webinar on Port Digitalization against COVID-19 Pandemic

Dr. Dong Yang was invited as one of the keynote speakers for the APRO Webinar on Port

Digitalization against COVID-19, held by APEC Port Service Network on 21 May 2021. He shared a recent study on how to build up a real-time port performance monitoring system with big data from the ship automatic identification system. The speech ends up with possible applications of such a platform in multiple scenarios, including port practice, shipping route design and shipping company's energy choices selection.
