

### **Shipping Research Ranking**

Researchers at PolyU have made outstanding contributions to shipping research. According to Clarivate Analytics' ISI Web of Science, PolyU tops the list among the world's leading shipping schools in shipping research, in terms of published papers in SSCI-indexed journals over the past three years.

The report shows that a total of 644 shipping articles were published in the Transportation category during 2019-2021, among which 64 papers were contributed by PolyU's colleagues. PolyU came first in the world ranking.





# Knowledge Transfer Forum on Contemporary Issues of Port Management

The 10th International Conference on Logistics and Maritime System on "Emerging Opportunities and Challenges of Maritime Logistics - Automation, Digitalization, and Artificial Intelligence" was successfully held in Zhoushan, China from October 29 to 30, 2021. More than 80 participants from the academia, industry, and government attended the conference to share cutting-edge research as well as innovative experiences and technologies. PhD student Tingting Han supervised by Dr. Dong Yang delivered a speech titled "Effect of Online Quote Capability in Liner Shipping", and won the "Second Best Student Paper Award" at the conference.







### Participate in IAME 2021

IAME2021 was successfully held on 25, 26, and 27 November 2021. This conference brings experts in all aspects of ports and maritime research worldwide to exchange relevant insights and research. SRC members participated in this conference and presented three research topics:

•Prof. Kee-hung Lai, Dr. Venus Lun, Dr. Dong Yang, Miss Chengkun Li, and student Lu Li shared a research topic on maritime industry relatedness of three typical maritime clusters: Western Europe, GBA, and YRD.

•Dr. Dong Yang, Prof. Theo Notteboom, and student Lu Li shared a research topic on whether Chinese enterprises' investment contributes to better port performance using quantitative methods.

•Prof. Kee-hung Lai, Dr. Dong Yang, and student Chung Lam Ng shared a research topic on conceptualizing shipping clusters with measurements.
