The Global Port Research Alliance (GPRA) 2015 will be held in Hong Kong. We are pleased to have received 100 abstracts co-authored by more than 200 authors from different countries.

The GPRA keynote sessions will include:

- Session 1: Liner Shipping Connectivity by United Nations Conference on Trade and Development (UNCTAD), and Logistics Performance Index by the World Bank
- Session 2: Global Terminal Operations by HPH, and International Transport Logistics by DHL

GPRA 2015 will also have two industry sessions organized by the Hong Kong Shippers' Council (HKSC) and the Hong Kong Sea Transport and Logistics Association (HKSTLA), six special sessions, a number of parallel sessions, and a plenary session.

The AGKN was launched by the University of Bremen as a web-based platform for communication and knowledge sharing between selected universities in China and Vietnam as a joint project funded by the Federal Ministry for Education and Research. The aim of this project was to develop and realize an approach on how to enhance the visibility of German research structures in the Asia Pacific Research Area (APRA) in the specific field of transport and logistics.

#### The goals of the AGKN are to:

- strengthen cooperative relations between German scientists and partners in countries of the Asia Pacific Research Area (APRA), both in education and research as initiator or equal partner of international research projects by including representatives from business and political areas;
- intensify the international network of German and Asian universities and research institutions according to the principle of social responsibility, and with the goal to foster international research and education in transport and logistics;
- raise visibility and knowledge exchange in the area of education and research in new above-average potential target regions in accordance with the respective national strategy for internationalization of science and research; and
- ensure permanent exchange of information and experiences about collaboration with foreign partners with superordinate, national, and local funding institutions.
