The Conference on Logistics and Maritime Studies (LMS) on One Belt One Road (OBOR) will be held on 10-11 May 2016 in Hong Kong. The blueprint of the OBOR initiative is connecting the vibrant East Asia economic circle at one end and the developed European economic circle at the other, and encompassing countries with huge potential for economic development. One of the key objectives of the OBOR initiative is to increase connectivity and economic development along both the land-based and oceangoing routes through the movement of goods, services, information, and people.

The LMS on OBOR conference will provide a forum to address various issues associated with the OBOR initiative from the perspectives of logistics and maritime studies. It will also serve as a platform to facilitate international research and industrial collaboration to examine the multifaceted issues related to the OBOR initiative.

Seminar on CBeC cum FTA

The seminar on Cross Border e-Commerce (CBeC) cum Guangzhou Nansha Free Trade Area (FTA) was held on 16 November 2015 at TU107 of The Hong Kong Polytechnic University (PolyU). The Guests of Honor of this event were Deputy Director of Guangzhou Nansha Development Zone Mr Li Zigen and Head of Department of Logistics and Maritime Studies (LMS) Prof. Andy Yeung.

Organized by the Hong Kong Sea Transport and Logistics Association (HKSTLA) and co-organized by the Shipping Research Centre (SRC), the seminar consisted of two parts. The morning section examined various issues on CBeC, Customs and China Inspection and Quarantine (CIQ). The afternoon section included presentations from Chinese officials on FTA and CIQ. Moderated by Dr Mike Lai and Dr Stephen Ng, a policy discussion was also conducted.

Authored by SRC members, the new book entitled Environmental Management: The Supply Chain Perspective was recently published.

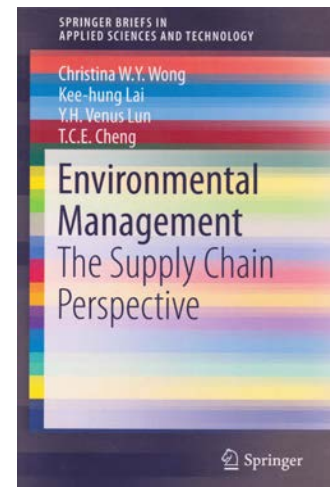
