## **Shipping Research Ranking**

Researchers at PolyU have made outstanding contributions to shipping research. According to Thomson Reuters' *ISI Web of Science*, PolyU tops the list among the world's leading shipping schools in shipping research, in terms of published papers in SSCI journals over the past three years.

The report shows that a total of 409 shipping articles were published in the Transportation category during 2013-2015, among which 31 papers were produced by PolyU. PolyU came first in the world ranking for the fifth consecutive time.

## **Keynote Speaker of APEC Gateway Port Connectivity**

Asia-Pacific Economic Cooperation (APEC) commissioned a study on "Promotion of Regional Economic Integration by Developing APCE Gateway Port Connectivity". The study aims to "develop policy and strategy recommendations for promoting Gateway Ports Connectivity in the APEC region, which refers to connections between regional seaports, and between seaports and their hinterland area".

A study workshop on this project was conducted on 5 September 2016 in Kuala Lumpur, Malaysia. Dr Venus Lun (SRC Director) was invited to deliver a keynote speech on "Positioning of gateway port, against competitions from more regional transshipment hubs and increasingly larger vessels".
