Panel Discussion: Bankruptcy of Hanjin Shipping

The incident of insolvency of Hanjin Shipping has caused turmoil in global sea freight and disturbed the global trade network. The SRC co-organized a panel discussion with the CILTHK on 27 October 2016 at N001 of PolyU. More than 100 participants attended this event. The panel discussion aimed to examine the following questions: What happened to Hanjin? What does Hanjin's collapse mean for world shipping? What will be the way forward for the shipping industry?

Public Lecture

A public lecture was held on 17 August 2016 at PolyU. The lecture, entitled Shipping as a Global Leading Indicator: The Use of Shipping Sentiment Indices, was presented by Nikos Nomikos, Professor of Shipping Risk Management, Cass Business School at City University of London.

Professor Nomikos and his team compile investor sentiment indices for various sectors of the shipping industry, which are used for anticipating turning points in vessel prices, and timing the sale and purchase of second-hand vessels. They demonstrate that shipping investor sentiment is a common leading indicator of global financial markets, in particular a contrarian predictor of stock market returns.
