

**D13. Technology Transfer Assessment Committee (TTAC)**

**Terms of Reference**

1. To consider and approve technology transfer and commercialisation cases, including impact classification of cases, forms of IP commercialisation (licensing or assignment) and key commercialisation terms (including acquisition of stock options and equity interest from licensee).
2. To review and recommend for the University's consideration of taking up equity interest/stock option from external entities<sup>1</sup>, including PolyU supported start-ups, through IP licensing or assignment.
