SFT Entry Scholarship for Outstanding HKDSE Students

School of Fashion and Textiles (SFT) accords recognition to outstanding HKDSE students admitted to the full-time BA (Hon) Scheme in Fashion via JUPUS and grants them scholarships of various amounts offered by the School.

How can I apply for the Entry Scholarship?

There is no need for students to apply separately for entry scholarships. SFT will identify outstanding applicants, and will inform you of the award of scholarships after the commencement of the school term.

Who is eligible?

All outstanding admittees to our full-time BA (Hon) Scheme in Fashion via JUPAS will be considered for the scholarships.

Academic Scholarship and Entry Scholarship for HKDSE Students

Outstanding full-time Bachelor's Degree programmes admittee will receive the Academic Scholarships for HKDSE students from the University if he/she fulfills the requirements on HKDSE attainment (please refer to Study@PolyU for details). In addition to the University Academic Scholarships, Entry Scholarship from SFT is guaranteed if the admittee fulfills any of the categories below:

Category I - Students attaining Level 5** in HKDSE subject(s)^

Tier	HKDSE Requirements	Scholarship Amount
1	Level 5** in 3 or more subjects	One-off scholarship of HK\$25,000
2	Level 5** in 2 subjects	One-off scholarship of HK\$20,000
3	Level 5** in 1 subject	One-off scholarship of HK\$15,000

Category II - Students with an aggregate HKDSE score of 27 or above for the Best 5 subjects#

Tier	HKDSE Scores	Scholarship Amount
1	29 or above	One-off scholarship of HK\$35,000
2	28	One-off scholarship of HK\$30,000
3	27	One-off scholarship of HK\$25,000

^ The Extended Mathematics modules will also be taken into account for scholarship consideration.

For the purpose of calculating the admission scores, HKDSE level attainments will be converted to level points where Level 5**=8.5, 5*=7, 5=5.5, 4=4, 3=3, 2=2, 1=1 and Unclassified=0.

Note: Students meeting the requirement for both categories will get the Entry Scholarships ONCE for whichever category of higher value, being capped at the maximum amount received by a student per academic year as stipulated by the University guideline⁺.

⁺ A student can concurrently hold more than one scholarship administered by the University in an academic year if the total value of scholarships received by him/her does not exceed his/her annual tuition fee payable plus HK\$50,000 unless otherwise stipulated.

Additional Scholarships for HKDSE students

Tier	HKDSE score	Additional Scholarships
1	Tier 1 in either Categories I or II above	Up to HK\$90,000 (apart from the entry scholarship above, additional scholarships may include hall scholarship of up to HK\$10,000 [#] , internship sponsorship of up to HK\$20,000 [#] , and student exchange scholarship of up to HK\$60,000 [#])
2	Tier 2 in either Categories I or II above	Up to HK\$45,000 (apart from the entry scholarship above, additional scholarships may include, hall scholarship of up to HK\$10,000 [#] , internship sponsorship of up to HK\$20,000 [#] , and student exchange scholarship of up to HK\$15,000 [#])

Note: students meeting the requirement for both categories will get the Entry Scholarships ONCE for whichever Tier of higher value, being capped at the maximum amount received by a student per academic year as stipulated by the University guidelines.

Students are required to meet the selection criteria and requirements of the internship sponsorship and student exchange scholarship.
