## **Ontario's Higher Education System**

- Universities: 25 (first established in 1827 and as recently as 2017). Independent Acts of Legislature
- **Colleges:** 26 (1967). Ontario Colleges of Applied Arts and Technology Act
- Indigenous institutes: 9. Indigenous Institutes Act, 2017.
- Private career colleges and universities
- Differentiated system; not designed for transfer



## **System Shifts**

**1980s:** No system-wide approach to transfer. A few universities grant credit for college learning. Labour market demand for degree graduates increases.

**1990s:** Colleges, frustrated by lack of opportunities for their graduates, put additional pressure on Government and advocate for new degree-granting institute.

**1996:** Ontario Ministry of Training, Colleges & Universities creates the **College University Consortium Council** in partnership with the Council of Ontario Universities and Colleges Ontario.

### **System Evolution**

#### 2011 Policy Statement for Ontario's Credit Transfer System

Ontario will have a comprehensive, transparent and consistently applied credit transfer system that will improve student pathways and mobility, support student success and make Ontario a postsecondary education destination of choice. The credit transfer system will assist qualified students to move between postsecondary institutions or programs without repeating prior, relevant learning (Ontario Ministry of Training, Colleges & Universities).



#### **Government Commitments**

**\$73.7M** towards credit transfer improvements over 5 years:

- 1. Creation of ONCAT
- 2. Creation of provincial web-portal for transfer info
- 3. Funding to institutions through Credit Transfer Institutional Grant

\$73.7M CDN= \$439M HKD, \$56.7M USD



#### **ONCAT Mandate**

Established in 2011, the Ontario Council on Articulation and Transfer (ONCAT) was created to **enhance academic pathways** and **reduce barriers for students looking to transfer** among **Ontario's public colleges, universities, and Indigenous Institutes.** 



#### **Key Accomplishments**

- 277,000+ credit equivalencies on ONTransfer.ca
- 100% of colleges and universities have posted transfer information on ONTransfer.ca
- 88% of students report satisfaction with credit transfer experience (up from 79% in 2015/16)
- 55% of transfer students have visited ONTransfer.ca and 96% of them find the information useful (2018/19)
- 67–84% of college diploma graduates have pathway(s) into degree studies (high affinity/broad discipline)



## **Current state of Ontario HE**

- Less differentiated system; multiple credential type
- Labour and student demand for 4 year degree still high
- Interest in career-oriented programs growing
- Majority of transfer pathways are bilateral, college to university. Despite transfer in multiple directions.
- College to university transfer policy focus has been less about access and equity; more about system efficiency and cost savings.
- Limited capacity for monitoring system performance.



#### Institutional Autonomy

**Universities:** Collegial governance, often bi-cameral governance and high institutional autonomy

**Colleges:** Independent Board of Governors, moderate autonomy

**Program Quality Assurance:** Multiple quality assurance bodies; Ministry approval (for tuition funding and financial aid eligibility)



## **Role of Government**

- ONCAT: Set Vision and Objectives, Transfer Payment Agreement
- System Policy Levers: Strategic Mandate Agreements, performance-based funding, special enveloped funding, policy statements, etc.
- System Policy Actions: Institutional reporting mechanisms, data analysis with unique student identifier, communications with institutional Executive Heads



### **ONCAT/Government Collaboration**



Underway:

- Developing Credit Transfer System Strategic Plan
- Coordination of strategic funding and system accountability efforts
- Better for People, Smarter for Business Act 2020
